

Kanab Middle School Community Council Minutes

Welcome: Mr. Bateman welcomed the community council members and thanked them for their willingness to serve. He also explained the importance of community council to newcomer Mary Cabella.

Nominations for Chair, Vice Chair and Secretary: Mr. Bateman explained the job descriptions for each role. Mariah Wheeler nominated Mary Kabella for Chair and Lexie Little seconded the nomination. Mary Kabella nominated Mariah Wheeler for Vice Chair and Lexie Little seconded the nomination. Lexie Little nominated herself for secretary and Mariah Wheeler seconded the nomination. A motion was made to nominate the individuals in the positions listed above. The motion passed.

He felt like removing the fees for one school year and then reimplementing fees would not go over well with parents. Therefore at the beginning of the school year they did charge a \$15 chromebook fee and a \$10 activity fee for each student. He wanted to inform the community council of his decision and the reasoning behind the decision. The council was in support of the fees.
